The Community Shelter Board's original Rebuilding Lives initiative has meant a new home and a new start for hundreds of people throughout Franklin County. The Rebuilding Lives Updated Strategy (RLUS) will undertake a comprehensive research and resources inventory of the current Rebuilding Lives plan as well as the family system. Results of this assessment will be used to develop an updated strategy to address the needs of homeless families, children and adults as one comprehensive plan. This plan will help our community to connect homeless adults and families to housing and services they need to break the cycle of homelessness.

Modeled after the successful Scioto Peninsula Task Force (which created the Rebuilding Lives plan), the Updated Strategy consists of a Steering Committee composed of community leaders, CSB staff providing primary project support, along with external consultants working on research and strategy development. These three components attest to the important private and public partnership that holds this project together, with funding as well as leadership coming from private, non-profit and public sectors.

Steering Committee Gains Valuable Insight

In response to discussion held at the first Rebuilding Lives Updated Strategy Steering Committee meeting in June 2006, a series of six discussion groups with tours were scheduled to give the members extensive insight to topics unable to be fully examined in the scheduled Steering Committee meetings. The goal is to increase members' ability to make effective decisions as it pertains to homelessness in our community.

On September 1st, the first group was given a glimpse of homelessness from the inside of an encampment. Touring the encampments provided insight to the characteristics and needs of persons experiencing street homelessness, the challenges they face, and the reasons some stay outdoors. In addition, they developed a basic understanding of the services provided, and strategies employed to engage and assist persons in encampments.

The next discussion and tour was hosted on September 14th at the Maryhaven Engagement Center. The tour and conversation offered the group a fundamental knowledge of the services the Engagement Center provides. The connection to alcoholism and its impact on homelessness was explored, as well.

The philosophy of treating long term addiction was examined during the tour at Community Housing Networks' North High. The discussion focused on the facility's philosophy and approach used in Stages of Change and the Harm Reduction Model, and some of the challenges encountered using these two models.

The fourth and fifth tours focused on the The Salvation Army Family Housing Collaborative (FHC) and the Amethyst Permanent Supportive Housing, respectively Each of these tours highlighted detailed information of the Housing First approach as it relates to families with children.

The effects of homelessness on youth will be reviewed on November 8th at the Huckleberry House. The role of Huckleberry House in our community the attributes of the youth served, and the challenges they face will be studied.

CSB hopes that the discussion groups and tours, will provide the Steering Committee with increased knowledge and familiarity of the system of services and housing for homeless people; and as a result ensure informed decisions


