## [BOARD2BOARD DIALOGUE]

We were pleased to host our contracted provider agencies for a meaningful conversation with our Board of Trustees on October 3. The event was attended by 28 provider agency executives and board members, and 8 CSB trustees and was hosted by Chad Jester at Nationwide.

The focus of the discussion was around the current funding reality and concern about lack of sustainability in the shelter system. We talked about both the redesign of the adult shelter system, and trends with family overflow. It was a great opportunity to access all the bright minds in the room as we move into a major transformation. We received thoughtful input in response to these questions:

- Regarding redesign of the adult shelter system, what else should we consider and what questions should we be asking ourselves as we move into this transformation?
- Regarding family overflow, what else can we do, as a community, to meet this need?
- What lessons have you learned about systems change that might help us as we navigate these transitions?

## [RESOURCE GENERATION]

#### **HUD Continuum of Care**

CSB is working to finalize the consolidated Continuum of Care Application to be submitted to HUD by October 28. This year's application will include 30 renewal applications from Amethyst, Inc., AIDS Resource Center of Ohio, Community Housing Network, Community Shelter Board, Huckleberry House, Maryhaven, National Church Residences, Southeast, Inc., Volunteers of America of Greater Ohio and YWCA Columbus.

An application for the 2011 Permanent Housing Bonus from Community Housing Network for Inglewood Court will also be included. In partnership with Maryhaven, CHN Inglewood Court will provide 60 units of permanent supportive housing for persons disabled by severe mental disability (SMD) or dually diagnosed with SMD and chemical dependency. 45 units are for Rebuilding Lives eligible homeless single adults. The 15 non-Rebuilding Lives units will be reserved for ADAMH consumers coming from Twin Valley Behavioral Healthcare or other funded ADAMH group homes. HUD anticipates announcing awards for renewal funding in late December 2011/early January 2012, while new project awards will not be announced until the spring of 2012.

## [REBUILDING LIVES]

#### **Unified Supportive Housing System**

The Unified Supportive Housing System Policy Council met on August 30 and agreed to continue with full implementation of the USHS, moving it from the pilot phase into implementation. *The 2011 Guide to the Unified Supportive Housing System* is now updated to contain the current model for the USHS – the new version can be found on CSB's website at www.csb.org.

The Unified Supportive Housing System has recently contracted for an LISW through Southeast to facilitate the USHS housing process, thanks to a grant from Cardinal Health. The LISW will be available to provide the much needed service of assessing disabilities for shelter and outreach clients. With this initiative we are hoping to reduce the time to housing for homeless and disabled individuals. This service is provided to individuals not connected to a medical or mental health professional. Individuals already linked with a medical or mental health professional are asked to continue to contact their provider to complete a *Certification of Disability* form.

To initiate the assessment process, case managers will include a completed *USHS Request for Disability Assessment* form in the client's USHS file. The assessment request form will be available on CSB's website under the USHS Eligibility Documentation section. Once the USHS Project Manager receives the completed USHS file, the *USHS Request for Disability Assessment* form will be forwarded on to the LISW, who will contact the client's case manager to schedule an assessment time.

The Unified Supportive Housing System is a collaborative effort managed by the Alcohol, Drug, and Mental Health Board of Franklin County, the Columbus Metropolitan Housing Authority and the Community Shelter Board. These partners are working

together with other agencies in the community including health, housing, shelter, and outreach providers. This work is sponsored by the Osteopathic Heritage Foundations, Fannie Mae, and Battelle. For more information please contact Isolde Teba, USHS Project Manager, at 614-221-9195.

## Data System Undergoes Upgrade

Columbus ServicePoint (CSP), CSB's communitywide homeless management information system, underwent a major upgrade September 30 – October 3. A precursor to the upgrade was a week-long training that was offered to all partner agency staff. The training was facilitated by a Bowman Systems trainer and 140 individuals completed a oneday training. Each individual was tested after the training and we had an overall 95% success rate. We would like to express gratitude to our partner agencies' staff for their patience and collaboration through this process and as we work through the kinks and adjustments of a fully reconfigured system. Positive growth always includes unexpected difficulties and we wouldn't be able to do it without the diligence and perseverance of the CSP Agency Administrators and their data entry staff.

#### **Fall Meetings with Providers**

In keeping with our annual practice, CSB and many of our partner agencies will be conducting fall one-on-one meetings this November. The fall meetings provide an opportunity for our partner agencies to make quality improvement suggestions and introduce topics for discussion on behalf of their clients. Currently, the majority of our partner agencies have scheduled meetings, and CSB looks forward to discussing new ideas for system-wide improvement. Meetings are scheduled from November 1 to November 18.

#### **Program Review & Certification Update**

The first wave of 2011 Program Review & Certification visits is complete, and we are pleased to report that our partner agencies continue their tradition of exemplary service by meeting the challenges necessary to achieve compliance. In order to achieve compliance, an agency has to meet over 100 different standards ranging from fiscal administration to program operations to data collection. The ability to meet compliance on all standards is just one example of the quality of work our partners do. The second wave of Program Review & Certification visits will begin on October 19.
