One Day to End Homelessness Campaign Results

The One Day to End Homelessness campaign kicked off with a very successful 10TV telethon on January 31 that raised \$101,000. The campaign urged Columbus and Franklin County residents to contribute the equivalent of just one day's rent or mortgage payment. Throughout the month of February, additional funds were raised by congregations and donated by community members through the website.



With the help of WBNS-10TV, the Dispatch Media Group, Nationwide, and the United Methodist Church, CSB raised over \$150,000. The funds raised will go to support CSB's nationally recognized programs.

A de-brief meeting with the Faith Leadership Council will occur on March 23.

Benefit Concert by the Harmony Project

The Harmony Project embraces the mission of building community through the vehicle of the performing arts. The Harmony Project will hold a spring concert benefitting the Community Shelter Board on May 12 at the Greater Columbus Convention Center.

This concert, entitled "Lift Every Voice: A Concert to End Homelessness," will feature the 150-voice Harmony Project choir, Jazz Arts Group, Project Hope Children's Choir, and the Unison Project Choir. The Harmony Project brings together a diverse group of people to become one voice through artistic collaboration and community service. The Unison Project Choir is a newly formed music and service program for community members experiencing the transition from homelessness to permanent housing. Residents from the Commons at Grant and the Commons at Buckingham make up the membership of the choir.

[ADVOCACY]

State and Federal Advocacy

Michelle has been busy this winter meeting with state and federal elected officials to advocate for preservation of funding for homeless programs. We are concerned about the Ohio Housing Trust Fund, Ohio's Local Government Fund, and federal McKinney-Vento funding.

We are advocating to keep the Ohio Housing Trust Fund intact because any loss in funding would result in reduced shelter beds and reduced housing units. Millions in private and federal dollars leveraged by Trust Fund projects will be lost, as will the jobs created by the leveraged funds. Nearly \$3.9 million is at risk for homeless programs in Franklin County. The Trust Fund supports programs at Amethyst, Community Housing Network, Community Shelter Board, Faith Mission, Homeless Families Foundation, National Church Residences, The Salvation Army, Southeast, and the YMCA of Central Ohio.

Our concern about Ohio's Local Government Fund is that a great deal of our City and County funding is dependent on the state budget. \$3.4 million in City funding and \$1.4 million in County funding is dependent on the Local Government Fund.

Federal McKinney-Vento funding is at risk as well. McKinney-Vento needs to be funded at least at the same level as last year in order for communities across the country to guard against the impacts of the recession. An increase is needed to start implementing the HEARTH Act.

Michelle has met with Rep. Cheryl Grossman, Senator Jim Hughes, and Ed Roberts and Ben Famous from Senator Sherrod Brown's office. In addition, letters have been sent and calls have been made to Rep. Steve Austria, Rep. Steve Stivers, Senator Charleta Tavares, and Rep. Patrick Tiberi. Rep. Steve Stivers is scheduled for a tour on March 23.

Winter Overflow

Winter overflow remains in effect for the single adult system. Although the average number of women served each night remained constant, the men's shelter dropped to an average of 141 in overflow per night. Winter overflow services will begin ramping down March 15 and will cease April 15. Adult shelter providers are focusing on moving people to housing as quickly as possible.

Fortunately, the family system has experienced a drastic drop in overflow usage and has not experienced any families in overflow since the last week of February. We hope this situation continues.

Collaborative Outreach Strategy

As mentioned in last month's issue, recommendations for the Rebuilding Lives Collaborative Outreach Strategy were presented to the Rebuilding Lives Funder Collaborative (RLFC) at its February meeting. As a result of the recommendations, a request for proposals has been developed and released to the community. The RFP is requesting the provision of outreach services and the development and implementation of a collaborative model for outreach. Proposals are due by 5:00 pm April 15, 2011. Gateway Application

The Gateway process for the upcoming fiscal year is underway, and FY12 Gateway applications are due to CSB by **5:00 pm on Thursday, March 17.** All applications will be reviewed in the final two weeks of March, followed in April by the spring 1-on-1 meetings with each partner agency. The meetings will provide an opportunity to discuss each agency's FY12 Gateway application and opportunities for continual quality improvement.
